Citations vs. CSA Points

Often times I will get the phrase "I got pulled over for xyz but he didn't give me a ticket". Typically, if you are pulled over they will still write up the reason or defect on your DOT inspection. They will not always issue a citation for it. With that said, just because you do not have monetary consequences, does not mean

you still did not get written up on your PSP.

A citation can be issued to the driver or the company. If it is issued

to the driver, you will see this appear on your motor vehicle report (MVR).

A DOT inspection is seen on 2 different levels

• As a carrier- it is on our Compliance Safety Accountability (CSA) score. Any violations, defects, or out of service for our DOT are public record and graded against peer carriers. These can be seen for the past 2 years and the points are multiplied (times 3 for 6 months, time 2 for 6 months to 1 year, single points for 1-2 years). Too many points can cause alerts which can cause more inspections or audits.

• As a driver- these can be seen on your Pre- Employment Screening (PSP) report. If you choose to get another job, a carrier can run this report and see all inspections/violations you have had in the last 3 years.

The best practice is to make sure you are prepared before taking off. Do a proper pre/post trip to prevent any write ups on your equipment. Most of our unsafe driving violations are speeds or left lane violations so be mindful of traffic laws along your travels. Top log violations are form and manner (forgetting to input shipping document numbers, trailer numbers, and certifying your logs).

Solar Eclipse- April 8th

a bit of a challenge when your job is being on the road from 1:55 PM- 3:10 PM on April 8th. Following the tips below will help keep

you safe.

- Drive with your headlights on
- Avoid looking at the sun without protective eyewear
- Do not watch the eclipse while driving. Do no park on the shoulder either- no sitting duck!
- Watch for pedestrians distracted by the sky
- Be extra alert for distracted drivers

Lock in your pins

When doing a pre/post trip, make sure your pins are locked in on your trailer tandems. Majority of the 51 series are engaged when you connect your air, but the 52 and 53 series are mechanical.

Some customers require you slide them to the back to drop,



but you want to make sure that pin is locked in before starting your trip.

Got your supplies handy?

Do you have the required materials in your truck? CFR 393.95 requires you to carry a fire extinguisher, spare fuses, and warning devices for stopped vehicles (triangles). We also recommend carrying hooks if you need towed. These items are small to store but can be easy violations to be written up for.
